Income Tax assessment year 2005-06 of Rs. 1686297/-

Dr. A.S. Thind, Registrar briefed the council members about the details of the Income Tax deduction and the payments made to the Income Tax Department. It was informed that a part of Rs. 2,00,000/- has already been made. The balance amount of Rs. 1486297/- has to be made to the department failing which a penalty has to be paid. To avoid paying penalty it was proposed that the payment be made on the maturity of FD's on 20-6-2007.

Council unanimously approved the proposal of the department. After the maturity of the FDR's the remaining amount be submitted in the Income Tax Department. The Council approved the action taken of the Council in the matter. It was also approved that the further steps may be taken after taking the advise of the Council's Advocate.
