**AGENDA ITEM NO. 1**

**Confirmation of the proceeding of the Punjab Medical Council meeting held on 12-12-2008.**

**PNDT case of Dr. Harbans Singh, Harbans Ultrasound and CT Scan Centre, Dhuri Road, Sangrur.**

The court has already acquitted Dr. Harbans Singh vide court order dated 18-12-2008 passed by Hon'ble Sh. K.B. Raheja, Chief Judicial Magistrate, Sangrur. The orders are reproduced below:-

*“In this case, the prosecution has failed to prove the guilt against the accused beyond all reasonable doubts. Keeping in view the facts and circumstances as discussed above and after weighing the entire evidence, on record, in the scale of judicial scrutiny, I find that it is not a fit case to record conviction against the accused. So, the accused is, hereby acquitted of the allegation leveled against him, by giving him benefit of doubt.*

**AGENDA ITEM NO. 8**

**Miscellaneous if any, with the permission of the chair.**

**i. Complaint against doctors of Ivy Hospital, Mohali as alleged by Mr. Vishal Dinanath Ranavat, Jaipur.**

Committee decided that the photocopy of the complaint and reply from doctors of Ivy Hospital, Mohali be sent to all members of the council and the case be put up in next meeting.

**ii. Renovation/ furnishing of the Bathroom of the office.**

The bathroom of the office is very old type. Committee decided to renovate the bathroom with complete English seat, washbasin, blower, taps and floor of the bathroom.

**iii. Purchase the Generator for office.**

The 4 to 5 hour daily power cuts in the Mohali. In the absence of the power the computer work is not done in the office. Committee decided to purchase silent generator for office use.

**iv. Complaint against Dr. Sanjay Saluja.**

The legal opinion was received from Advocate B.S. Walia. In his opinion Advocate opined that :-

*“In the circumstances, in the absence of any finding by a Forum/ Court, of deficiency in rendering medical treatment/ of being criminally liable or for that matter of disciplinary proceedings having been initiated against the doctor in question/ of action having been recommended against the said doctor/ punishment having been imposed, it would not be advisable to withhold a certificate of good standing.”*

From the above the case discussed in detail in the meeting and the committee decided that the following certificate be issued to Dr. Sanjay Saluja :-

*“Certified that Dr. Sanjay Saluja, M.B.B.S., S/o Sh. S.S. Saluja is registered with Punjab Medical Council under registration No. 24244 dated 19-9-1986. His name is still valid in the State Medical Register.”*

**v. Renewal of Registration**

Committee has decided that Letter be issued to Govt. of Punjab for amendment in Punjab Medical Registration Act, 1916 regarding renewal of registration.

Notice be issued to newspaper for increase the date of renewal till the 30<sup>th</sup> June 2009.

**vi. Conference**

Committee has decided to hold 2 conferences at Jalandhar and Faridkot. Dr. A.S. Thind will organise a conference on Drug Problem at Faridkot and Dr. P.S. Bakhshi organise a conference on Female Feticide at Jalandhar. In this regard letter be issued to concerned doctors.
