3. Medical Register/ Electoral Roll

Registrar apprised the council members the position of registration. Up to 31-07-2004, 34409 doctors were registered with the Punjab Medical Council. The name of the doctors who had responded (up to 31-3-2004) as a result of public notice were included in the Medical Register/ Electoral. 12712 doctors out of 34409 doctors registered with Punjab Medical Council had responded. The names have been updated. At present 35289 doctors have been registered with the council up to 29-8-2005.

The council unanimously decided that the name of all the doctors who have responded to the public notice and who have been registered with the council up to date be included in the electoral roll of the council

Proceedings of the Disciplinary committee/ Ethical committee were approved.
