

**PROCEEDING OF THE MEETING OF PUNJAB MEDICAL COUNCIL

- 1. Confirmation of the proceedings of the Punjab Medical Council meeting held on 24-4-2005.**

The proceeding of the council meeting held on 24-4-2005 at 10:00 AM were circulated to all the members vide office letter No. PMC/20052228-3 dated 7-7-2005. The council unanimously confirmed the proceedings dated 24-4-2005.

The Distt. Appropriate Authority, PNDD Act cum Civil Surgeon, Amritsar has written to the council to take action u/s 23 (2) under PNDD Act, 1994-Amended No. 19 of 2002 against the owner and Radiologist of Satyam Ultrasound Centre, I/s Ohri Nursing Home, G.T. Road, Putlighar.

Appropriate Authority cum Senior Medical Officer Incharge Civil Hospital, Malerkotla has requested to take action against Dr. Reena Jain and Dr. Surinder Kumar Jain, M/s Surindera Ultrasound Scan, Jain Nursing Home, Malerkotla.

On the recommendation of the President legal opinion was sought from Mr. Ravinder Kaushik, Senior Advocate, Patiala .

The case was discussed in detail. Keeping in view the legal opinion and various provisions under the PNDD Act, 1994 and amendments thereof the council is of the opinion that strict action as per rules be taken against these doctors.

The council approves the suspension/ removal of the names of these doctors from the register maintained in the Punjab Medical Council. The council further authorizes the President to take appropriate action against these doctors and also in similar cases in future.

- 3. Confirmation of Regular staff of the Punjab Medical Council.**

The council decided to defer this agenda item for next meeting.

- 4. Sanction of refundable/ non-refundable advance from Contributory Provident Fund as per Punjab Government Rule applicable on GPF**

The council unanimously approves the sanction of refundable/ non-refundable advances from Contributory Provident Fund as per Punjab Government rules applicable to the Government employee for General Provident Fund.

5. Complaint against :-

1. Dr. Ujjagar Singh Suri, Balachaur.

The Civil Surgeon, Nawanshahar has requested to take action against Suri Clinical Balachaur. He has requested to cancel the registration of Dr. Ujjagar Singh Suri registration No. 1974.

The council is of the opinion that since the doctor is registered with Board of Ayurvedic and Unani System of Medicine, Punjab. The complaint be referred to The Board to take necessary action.

2. Dr. Sukhdev Singh Rummy, Jagraon

The Deputy Commission Ludhiana, vide letter No. 407/CDA Spl. Dated 23-12-2004 has submitted a complaint against Dr. Sukhdev Singh Rummy, Civil Hospital, Jagraon.

The doctor was ordered to bring the record on 6-4-2005. The doctor did not attend the office. The record pertaining to the case was received from SMO Sudhar. Deputy Commissioner, Ludhiana has sent the detailed report regarding negligence committed during the operation.

The council is of the opinion that the record be subjected to strict scrutiny before taking any action against Dr. Sukhdev Singh Rummy.

Dr. Neeti Rajan Singh, Vice President is requested to study threadbare the papers pertaining to the case and further requested to submit the report. The case will be discussed in the next meeting.

3. Dr. Surinder Singh Punshi.

The case pertains to a new item published in the Hindustan Times dated 11-9-2003 against a fraud abroad by Dr. Surinder Singh Punshi and Mrs. Luxmi Nadgir.

Dr. Surinder Singh Punshi is registered with Punjab Medical Council under regna. No. 18324 dated 9-9-1977. The professional address by Doctor is 235, Jalam Petri, J.Bahan, Jolone, West Malaysia. A letter was sent on the above address. The letter has since been received by this office undelivered.

The council is of the opinion that the letter through Malaysian/American Embassy be sent for explanation why the action should not be taken against the doctor for removal of his name from the register maintained in the council.

4. Dr. Raghbir Singh Mann & Jyoti Mann, Ludhiana.

An anonymous complaint has been received from the resident, Model House, Model Town, Ludhiana against a RMP doctor doing practice. The case is discussed in detail.

The council is of the opinion that the case be referred to SSP, Ludhiana to investigate and take appropriate action against the doctors. The copy be endorsed to Civil Surgeon, DHS, SMER, SHFW.

5. Dr. Tejinder Kataria, Rajiv Gandhi Cancer Institute & Research Centre, Delhi.

The case was discussed in detail. The council is of the opinion that the opinion of Radiologist and Oncologist be taken. The case be put up for decision in next meeting.

6. Objectionable Advertisement of Arora Clinic, Mohali.

The case was discussed in detail. The doctor is giving advertisements in the press. He is not a qualified doctor. The council is of the opinion that the case be referred to SSP, Ropar for filing a FIR against the

doctor under various provision of law. The copy be endorsed to DGP, Civil Surgeon, DHS, SMER and SHFW.

7. Public Notice regarding Advertisement.

It was unanimously decided that a Public notice be inserted in the press to highlight and inform the medical practitioners about the ethical advertisements. Dr. Balraj Gupta the member of the council was entrusted to frame guideline/ proposal regarding advertisements in the meeting held on 24-4-2005. Dr. Balraj Gupta is not present today. He be requested to submit the guideline/ proposal at the earliest.

8. Any other item with the permission of the chair.

Continue Medical Education (CME). Vice President Dr. Neeti Rajan Singh submitted the proposal/ guidelines for CME.

Dr. Gursharan Singh was entrusted to frame amendment and rules keeping in view the present status. Dr. Gursharan Singh was unable to attend this meeting. Dr. Gursharan Singh be requested to submit the proposed amendments.

Dr Yash Kumar Sharma submitted a copy of Punjab Kesri dated 12-6-2005. There is an advertisement regarding organizing a camp for the "Pathari Rogiyon Hetu Nishulak Camp" along with Mobile Telephone No. 98150-89400. This information has been inserted to Sh. Manjit Singh, Manager Siddharth Stone Clinic, Ludhiana. It was resolved that the notice be issued to the hospital.
