**PROCEEDING OF THE MEETING OF THE PUNJAB MEDICAL COUNCIL
UNDER THE CHAIRMANSHIP OF DR. MANMOHAN SINGH, PRESIDENT
HELD ON 23.11.2004 AT 2.00 PM**

Registrar Dr. A.S. Thind welcomed the president and members of the council. Dr. Neeti Rajan Singh, Vice president and Dr. Amrik Singh Bhatia, Member informed the council that they are unable to attend the council meeting due to demise of the relative of Dr. Neeti Rajan Singh. With the permission of the chair the meeting started. The agenda items already circulated were discussed one by one and the following decisions were taken.

Item No. 1: Confirmation of the minutes of the meeting held on 12.9.2004.

The council unanimously confirmed the proceedings of the meeting held on 12-9-2004 under the chairmanship of Professor Man Mohan Singh, which was circulated, vide PMC letter No.2004/5061-67 dated 12-10-2004.

Item No. 2: Restoration of name of Dr. Sumeet Sofat, Registration No. 27618

The Registrar is empowered to erase from the Register the name of any registered person with whom he is unable to establish communication. The relevant portion of the Punjab Medical Registration Rules, para 7-A is reproduced below:

“The Registrar is empowered to erase from the Register with the written approval of the President the name of any registered person with whom he is unable to establish communication provided that any name so erased may be

reentered in the register by directions of the Medical Council upon payment of a fee of Rs. 500/- “

Imposing the clause 7-A of the said rules the name of Dr. Sumeet Sofat was erased from the Registered maintained in this office vide letter No. PMC/2004/5000 dated 12-10-2004. The doctor had surrendered the registration certificate to the council. He has attended the office of the Registrar with the request to re-enter his name in the Register. The doctor has also submitted an affidavit in the council office. The request was placed before the council for consideration/ and re-entry of the name of the doctor. The council unanimously decided to re-enter the name of the doctor in the register without prejudice to the pending enquiry on the complaint against the doctor regarding objectionable advertisement.

Item No.3: Restoration of name of Dr. Sumita Sofat, Registration No. 27513.

Imposing the clause 7-A of the said rules the name of Sumita Bedi, No. 27513 was erased from the Registered maintained in this office vide letter No. PMC/2004/5000 dated 12-10-2004. The doctor had surrendered the registration certificate to the council. He has attended the office of the Registrar with the request to re-enter his name in the Register. The doctor has also submitted an affidavit in the council office. The request was placed before the council for consideration/ and re-entry of the name of the doctor. The council unanimously decided to re-enter the name of the doctor in the register without prejudice to the pending enquiry on the complaint against the doctor regarding objectionable advertisement.

Item No. 4: Finalization of Nursing Home/ Clinics Registration proforma.

The proposed Nursing/ Clinics Registration proforma was discussed in detail and was unanimously passed with amendments. The performa shall be filled by all the clinics/ hospitals run by the registered medical practitioner in the State of Punjab. Members were asked to collect information from the other councils of other states about the prevalent rules under their councils.

Item No. 5: Discussion regarding new Nursing Registration Act.

The council unanimously decided and authorized the President to discuss and take appropriate steps with Secretary, Medical Education & Research/ Secretary Health & Family Welfare/ Director Research & Medical Education/ Director Health Services/ managing Director, Punjab Health System Corporation.

Item No. 6: Constitution of District Level Committee.

The council unanimously decided and authorized the President to nominated members of the council for the various District level committees and to nominate eminent doctor of the specialty concerned. The Registrar was authorized to communicate with the Government in connection with issuing of the letter of the committees. All the districts including the Police districts to be divided amongst the council members. The President was authorised to allocate the districts among the members.

Item No. 8: Any other item with the permission of the chair

- a. The council unanimously decided and authorized the Registrar to take necessary steps for the launch of the web site. He was authorized to engage the professionals in the matter.
- b. Registrar was asked to write letters to the all the DDO in the State of Punjab for the stoppage of the salary of doctors under them if they have not got themselves registered with the Punjab Medical Council. The letter should also be written to the Presidents/ Secretaries of the Indian Medical Association.
- c. It was felt that the work of Disciplinary Committee/ Ethics Committee is much more than expected. The President was authorized to appoint clerks/ steno typist for the work.
- d. The President was unanimously authorized to go through the complaints and forward to Disciplinary Committee/ Ethics Committee. It was also
