PUBLIC NOTICE

It is for information of all the Registered Medical Practitioners registered with Punjab Medical Council the Government of Punjab has ordered the renewal of registration after every five years vide Punjab Government notification No.11/47/2007-3HB3/2749 dated 29.04.2008. The Notification is reproduced below for your kind information:-

“The Governor of Punjab is pleased to notify that every Registered Medical Practitioner shall get his registration renewal after 5 year and must obtains 50 hour of Continuing Medical Education (CME), 10 hour per year, on payment of renewal fees. The renewal fee shall be Rs.500/- for each five years and as amended from time to time. In the absence of such renewal the registration of Registered Medical Practitioners will be suspended with the expiry of the registration.”

All the Registered Medical Practitioners are requested to apply to the Punjab Medical Council on specified proforma for the renewal of the registration as per schedule alongwith following documents :-

1. Renewal Registration Form
2. 2 Photograph 1 attested and 1 non attested
3. Photostat attested copy of Permanent Registration Certificate.
4. Fee Rs. 550/- including postage charges etc.
