PUBLIC NOTICE

This is for the information of all "Registered Medical Practitioners" (Doctors) registered with Punjab Medical Council under Punjab Medical Registration Act., 1916 and The Punjab Medical Registration (Amendment) Act, 2010.

As per the Punjab Medical Registration (Amendment) Act, 2010, Notification dated 25 Nov., 2010, vide section 13B.

"Every registered Practitioner shall get his registration renewed after every five years within a period of two months from the date of the expiry of his previous registration on payment of the prescribed fee":

It is hereby informed that the updated list of Registered Medical Practitioners (Doctors) registered with Punjab Medical Council has been prepared in the office of the Punjab Medical Council, on the basis of renewal of registration i.e. Doctors who have renewed their registration up to 25.4.2011. Notice for renewal had been given through several public notices in the Press and letters to the office of the Director Research & Medical Education, Punjab/Director Health Services, Punjab and all the branches of Indian Medical Association in the State of Punjab etc. from time to time. The same list is placed on the official website <http://www.punjabmedicalcouncil.com>. The claim / objections, if any, may be submitted on or before 31.5.2011 along with proof of registration, so that same is incorporated in the list. **Any body desirous of getting his/her name included is given another chance to have his/her registration renewed & get his/her name included in the list by 31.5.2011.**

Further names of Registered Medical Practitioners (Doctors) who do not have validly renewed registration upto 31.5.2011 will be liable to be **deleted** from the Medical Register maintained in the office of Punjab Medical Council after adopting the due procedure. This applies to Doctors working both in Govt. Sector & Private Sector.

If no claim/ objections is received by due date i.e. 31-5-2011 it will be presumed that the said list is final & correct. The same list will be considered as Electoral Roll for the purpose of council election which is likely to be held in near future. Punjab Govt. has appointed Dr. A.S. Thind, Joint Director Research & Medical Education, Punjab/Registrar Punjab Medical Council as Returning Officer vide its notification No.13/5/2001-3HBIII/2226-28 dated 15.03.2011 for the conduct of election of members of the Punjab Medical Council under clause (1) (c) of section 5 of the Punjab Medical Registration (Amendment) Act, 2010. Elections to the Punjab Medical Council are to be held shortly.
